From January to September 2018, there were 49 reports of on-farm deaths with tractors, utilities, quads and motorbikes most often implicated. The same period saw 120 non-fatal on-farm injury events, 16 of them involving children under 15. Quad bikes and motorbikes accounted for around a third of all incidents.</p>
